**LEGAL AID SOCIETY OF MID-NEW YORK, INC. NOMINATES TWO  
OUTSTANDING ATTORNYs AND ONE LAW OFFICE FOR NYSBA PRO BONO  
AWARDS**

(UTICA, NY) The Legal Aid Society of Mid-New York, Inc. has nominated Attorney Robert H. Wedlake (6th Judicial District), Attorney Susan McNeil (5th Judicial District), and the law office of Mucci & Grace (law office under 50 employees) to the New York State Bar Association's annual Pro Bono Awards.

"We provide free legal information, advice, and representation to people who are unable to afford a lawyer. Pro Bono attorneys work in partnership with LASMNY staff to expand our ability to provide civil legal services to a larger number of clients and communities. We are so grateful for all of our volunteers," Executive Director Paul Lupia, Esq, said.

Attorney McNeil joined the Syracuse firm of Satter Ruhlen Law Firm, PLLC. There she primarily focuses on labor and employment law issues. Attorney McNeil joined our Pro Bono panel in 2018 when Legal Aid contacted her to ask if she would be willing to assist a local veteran with an employment issue. Ms. McNeil readily agreed and ultimately spent over 100 hours over eight months, diligently and zealously advocating on behalf of this veteran.

cases are high stakes because a family can be homeless within 72 hours if the court issues a warrant of eviction. Attorney Wedlake's services are especially vital given these circumstances.
